Florida Scholarship Partnership

ELEV8 Schools partners with Step Up For Students to accept eligible Florida scholarship funding.

Families are strongly encouraged to apply for scholarship funding as early as possible. Scholarship approval, award amount, and funding timelines may vary based on the student's eligibility, county, grade level, scholarship program, special education status, and Step Up For Students approval process.

Scholarship funding is not guaranteed until the student is approved by Step Up For Students and funds are available in the applicable scholarship account.

Out-of-Pocket Tuition by Household Income

Our standard \$350 registration fee applies to all students unless waived in writing by school administration. This fee helps support enrollment processing, document review, placement coordination, scheduling, and administrative setup.

Families may qualify for tuition accommodations based on scholarship approval, income range, enrollment timing, program placement, and completion of required enrollment documents.

Monthly Payment Options

Regular School Monthly Payments

Monthly payment plans are based on a 10-month payment schedule unless otherwise approved in writing.

*Parents who commit to paying their **full tuition** in one payment will get their registration fee waived and tuition reduced by 50%

SPORTS Program Monthly Payments

SPORTS Program tuition will be determined during the admissions review process. Pricing may vary based on scholarship status, athletic programming, coaching support, facility usage, training requirements, student services, and administrative approval.

STEM AI Program Monthly Payments

STEM AI Program tuition will be determined during the admissions review process. Pricing may vary based on scholarship status, access to technology, robotics and artificial intelligence curriculum, student support services, equipment needs, software access, and administrative approval.

Early Completion Tuition Accommodation

For Regular School students, up to 50% of the annual out of pocket tuition may be waived if:

The student pays up front the 50%

The student receives scholarship approval from SUFS

The family completes the full enrollment application within five calendar days of the initial enrollment inquiry.

All required enrollment documents are submitted within the same five-day calendar period

The student is approved for placement by ELEV8 Schools

Any tuition accommodation must be approved in writing by ELEV8 Schools. Verbal discussions, estimates, or preliminary admissions conversations do not create a final tuition waiver.

Mid-Year Enrollment and No Scholarship Policy

If a student enrolls after the school year has begun and does not yet have an approved scholarship, the family remains responsible for tuition payments during the enrollment period.

Scholarship delays, denials, incomplete applications, parent delays, missing documents, or funding reductions do not automatically relieve the family of financial responsibility.

1st Semester Fee: Must have a scholarship.

2nd Semester Fee: \$2500++* for January 1st through May (Online Only)

**To qualify for this reduced mid-year tuition structure, the student may be required to:*

- Apply for all applicable VR-related programs
- Participate in required student support programs.
- Complete three internships when assigned.
- Complete graduation-related program requirements
- Maintain attendance, academic progress, and program participation
- Submit all documents required by ELEV8 School or affiliated program partners

The standard \$350 registration fee may be waived upon successful completion of required VR-related program requirements (3 programs completed) through self-advocacy, work readiness, WBLE, or OJT services, subject to school approval.

Additional student participation requirements may apply depending on the student's educational pathway.

Once scholarship funding is approved and received, tuition obligations may be adjusted based on the student's actual scholarship award, the remaining school-year balance, and the approved financial agreement.

Required Program Participation, When Applicable

Depending on the student's pathway, ELEV8 Schools may require participation in additional programs to support academic progress, career readiness, graduation, and postsecondary preparation.

Possible required programs may include:

- Self-Advocacy Training
- Work Readiness Training
- Work-Based Learning Experiences (WBLE)
- On-the-Job Training (Job Transitioning Services)
- Post Secondary Counseling
- Interview preparation
- Educational Campus Tours
- Any required program list should be provided to the family in writing before final enrollment approval.

Personal Guarantee and Collection Policy

By enrolling a student at ELEV8 Schools, the parent or legal guardian acknowledges and agrees that:

1. The enrollment agreement is a legally binding financial commitment for the agreed enrollment term.
2. The parent or legal guardian personally guarantees payment of all tuition, fees, program costs, technology costs, registration fees, and any additional agreed educational expenses.

3. The student may be required to meet academic, attendance, behavioral, internship, graduation, or program participation expectations, but financial responsibility remains with the parent or legal guardian unless the student is a legally responsible adult signer.
4. In the event tuition or fees are unpaid, ELEV8 Schools and its affiliated entities reserve the right to pursue collection of unpaid balances through all lawful collection methods available.
5. Collection efforts may include:
 - Internal collection procedures
 - Third party collection agencies

Legal action

Recovery of court costs and reasonable attorney's fees where permitted by law

1. Failure to make payments may result in suspension of services, removal from optional programs, cancellation of enrollment, or withholding of records where legally permitted.
2. Scholarship delays, denials, reductions, or parent failure to complete scholarship requirements do not eliminate the financial responsibility of the parent or legal guardian unless otherwise agreed to in writing by ELEV8 Schools.
3. Any missed payment may incur a \$15 late payment fee.
4. Any unpaid balance may incur an additional late payment penalty if allowed under the signed agreement and applicable law.
5. Any unpaid balance remaining after the end of the school year may accrue interest at a lawful annual rate until paid in full, subject to applicable law and the final signed enrollment agreement.
6. Families who pay the full annual tuition upfront at enrollment may receive a 30% tuition discount, subject to school approval, scholarship coordination, and written confirmation.

7. Parents or legal guardians enrolling in monthly payment plans authorize ELEV8 Schools and its affiliated payment processors to process recurring ACH bank drafts, debit card payments, credit card payments, or other approved electronic payments for agreed tuition, fees, and educational expenses.
8. Parents or legal guardians are responsible for maintaining a valid payment method on file at all times during enrollment.
9. Any failed ACH withdrawal, declined credit card transaction, returned payment, or insufficient funds transaction will result in processing fees, late fees, suspension of services, or other account restrictions until the account becomes current.
10. ELEV8 Schools reserves the right to require automatic ACH or card autopay enrollment for families participating in monthly payment plans.

School Year Commitment Policy

Enrollment at ELEV8 School is considered a full 10-month and 180-day commitment.

By enrolling, families acknowledge that:

1. Tuition payments reserve the student's placement, staffing, curriculum access, student support services, technology access, and operational resources.
2. Scholarships are applied based on approval, funding availability, and Step Up For Students funding timelines.
3. Families enrolling without scholarship approval remain financially responsible until the scholarship funding is approved, becomes available, and is received.
4. Withdrawal from the program does not automatically release tuition obligations already committed for the enrollment period.
5. Payment plans may be offered at the discretion of the school administration.
6. Any tuition adjustment, waiver, accommodation, or modified payment schedule must be approved in writing by ELEV8 Schools.

Additional Notes

1. Tuition accommodations may be available for families enrolling multiple children.
2. Extenuating financial circumstances may be reviewed by the administration.
3. SPORTS and STEM AI tuition adjustments require administrative approval.
4. VR related program costs may vary depending on student eligibility, participation level, technology access, internship requirements, and program expectations.
5. ELEV8 Schools reserves the right to adjust tuition structures, program pricing, scholarship coordination policies, and payment options annually.
6. All scholarship awards remain subject to Step Up For Students approval, funding availability, program rules, and applicable law.
